Questions to clients and accommodation prior to site visit:

If the entity answers YES to any of the questions 1 to 7 below, then a further conversation will be required before a site visit is allowed. These questions apply to all employed personnel on the site as detailed above.

- 1. Have any of your onsite staff returned from overseas or from an Australian hotspot in the past 14 days? Y/N
- 2. Have any of your onsite staff's household family members or their household friends returned from overseas or from an Australian hotspot in the past 14 days? Y/N
- 3. Have any of your onsite staff been confirmed to have COVID-19, including anyone waiting for test results in the past 14 days? Y/N
- 4. Have any of the onsite staff's household family members or their household friends had contact with any confirmed cases of COVID-19, including anyone waiting for test results, in the past 14 days? Y/N
- 5. Have any of your onsite staff been suspected to have COVID-19, including anyone waiting for test results in the past 14 days? $\,$ Y / N
- 6. Have any of your onsite staff's household family members or their household friends had contact with any suspected cases of COVID-19, including anyone waiting for test results, in the past 14 days? Y/N
- 7. Have any of your onsite staff had any symptoms of COVID-19, including, flu-like or respiratory symptoms, a fever, cough, sore throat, shortness of breath? Y/N

- 8. Have you applied COVID-19 procedures at your site? Y/N

During the site visit

If all parties are comfortable for Sutikely to visit and/or for work to proceed, please ensure all onsite staff adhere to the latest social distancing requirements as set out by the Government. See health.gov.au for more information.

This includes:

- 1. Hand hygiene washing hands for at least 20 seconds and use a hand sanitiser regularly.
- 2. Maintain a distance of at least 1.5 metres and within closed spaces there should be no less than four square metres of space per person.
- 3. Do not shake hands or make physical contact.
- 4. Maintain a distance of at least 3 metres from the machine whilst it is being worked on.
- 5. Wear a mask when coming within 3 metres of the machine being worked on after gaining approval to approach within 3 metres.
